Immigrant population

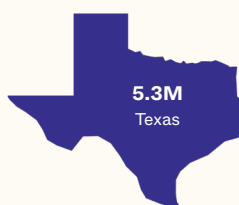
Immigrants make up an important part of local communities in Bexar County and Texas. Nonetheless, no noncitizen is exempt from the risk of deportation, which threatens the stability and family unity of immigrants and U.S.-born people alike.

285,500 immigrants reside in **Bexar County**, or **14 percent** of Bexar County's population.

5.3 million immigrants reside in **Texas**, or **18 percent** of the total population.

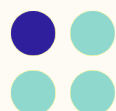

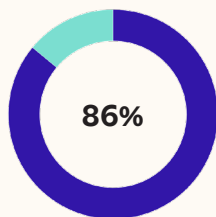

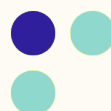


The **vast majority of children** in Bexar County with at least one immigrant parent (**86 percent**) were born in the United States.

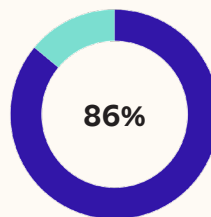

231,600 immigrants residing in Bexar County have lived in the United States for **10 years or more**.



At least **104,000** homes in Bexar County are **owned by immigrants**.



19,500 immigrants in Bexar County are **entrepreneurs**.



32,600 immigrants in Bexar County are **students** enrolled in pre-K through college or graduate school.

Immigrants in the economy

Immigrants in Bexar County, Texas, and the United States are indispensable members of the workforce and contribute to the economy by paying federal, state, and local taxes.

Tax contributions*

Texas

\$234.3B Immigrant-led households **earned \$234.3 billion**.

\$19.3B Immigrants contributed **\$19.3 billion** in combined **state and local taxes**.

\$38.8B Immigrants contributed **\$38.8 billion** in **federal taxes**.

\$176.3B This means that immigrant-led households have an estimated **\$176.3 billion** in **spending power**.

United States

\$2.35T Immigrant-led households **earned \$2.35 trillion**.

\$232.1B Immigrants contributed **\$232.1 billion** in combined **state and local taxes**.

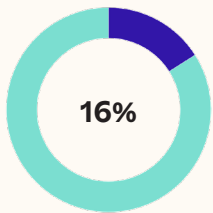
\$419.8B Immigrants contributed **\$419.8 billion** in **federal taxes**.

\$1.7T This means that immigrant-led households have an estimated **\$1.7 trillion** in **spending power**.

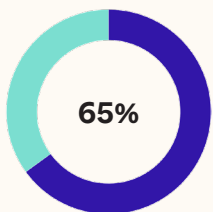

Bexar County

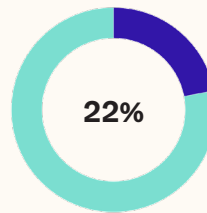


174,700 immigrant workers make up **16 percent** of the county's labor force.

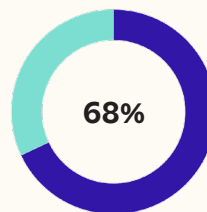


65 percent of the county's immigrants **participate in the labor force**, comparable to the share among the county's U.S.-born population (66 percent).

Texas



3.4 million immigrant workers make up **22 percent** of the state's labor force.



68 percent of the state's immigrants **participate in the labor force**, comparable to the share among the state's U.S.-born population (65 percent).
