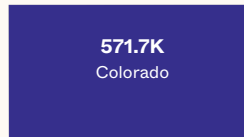


Immigrant population

Immigrants make up an important part of local communities in Colorado and the United States. Nonetheless, no noncitizen is exempt from the risk of deportation, which threatens the stability and family unity of immigrants and U.S.-born people alike.

Colorado



571,700 immigrants reside in **Colorado**, or **10 percent** of Colorado's population.

United States



47.3 million immigrants reside in **the United States**, or **14 percent** of the total population.

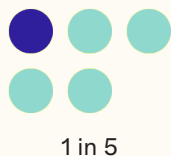

Children and families

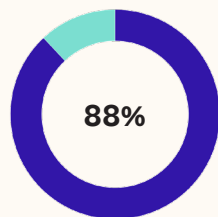
Colorado

There are **259,000** children in Colorado with at least one **immigrant parent**.



One in five children in Colorado has at least one **immigrant parent**.



The **vast majority of children** in Colorado with at least one immigrant parent (**88 percent**) were born in the United States.

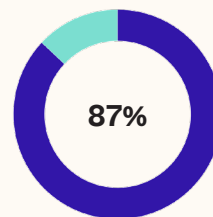
United States

There are **18.7 million** children in the United States with at least one **immigrant parent**.



One in four children in the United States has at least one **immigrant parent**.



The **vast majority of children** in the United States with at least one immigrant parent (**87 percent**) were born in the United States.

Local community ties



482,900 immigrants residing in Colorado have lived in the United States **for 10 years or more**.



At least **213,600** homes in Colorado are **owned by immigrants**.



27,800 immigrants in Colorado are **entrepreneurs**.



70,800 immigrants in Colorado are **students** enrolled in pre-K through college or graduate school.

Immigrants in the economy

Immigrants in Colorado and the United States are indispensable members of the workforce and contribute to the economy by paying federal, state, and local taxes.

Tax contributions*

Colorado

\$29B Immigrant-led households **earned \$29 billion**.

\$2.5B Immigrants contributed **\$2.5 billion** in combined **state and local taxes**.

\$5.2B Immigrants contributed **\$5.2 billion** in **federal taxes**.

\$21.3B This means that immigrant-led households have an estimated **\$21.3 billion** in **spending power**.

United States

\$2.35T Immigrant-led households **earned \$2.35 trillion**.

\$232.1B Immigrants contributed **\$232.1 billion** in combined **state and local taxes**.

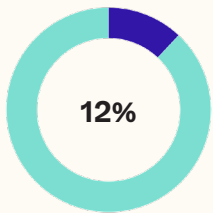
\$419.8B Immigrants contributed **\$419.8 billion** in **federal taxes**.

\$1.7T This means that immigrant-led households have an estimated **\$1.7 trillion** in **spending power**.

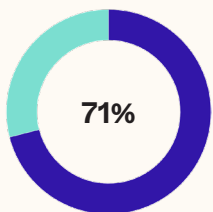

Employment and labor force participation

Colorado

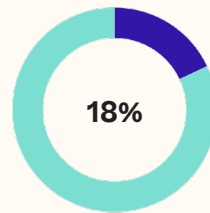


387,600 immigrant workers make up **12 percent** of the state's labor force.

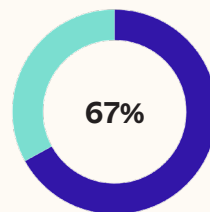


71 percent of the state's immigrants **participate in the labor force**, comparable to the share among the state's U.S.-born population (68 percent).

United States



30.2 million immigrant workers make up **18 percent** of the country's labor force.



67 percent of immigrants **participate in the country's labor force**, greater than the share among the U.S.-born population (63 percent).
