Immigrants make up an important part of local communities in Contra Costa County and California. Nonetheless, no noncitizen is exempt from the risk of deportation, which threatens the stability and family unity of immigrants and U.S.-born people alike.

Contra Costa County



310,100 immigrants reside in **Contra Costa County**, or **27 percent** of Contra Costa County's population.

California



10.6 million immigrants reside in **California**, or **27 percent** of the total population.

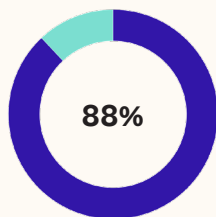

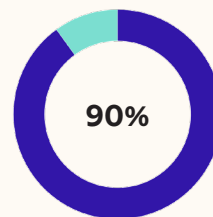

274,700 immigrants residing in Contra Costa County have lived in the United States **for 10 years or more**.



At least **105,800 homes** in Contra Costa County are **owned by immigrants**.



15,600 immigrants in Contra Costa County are **entrepreneurs**.



31,200 immigrants in Contra Costa County are **students** enrolled in pre-K through college or graduate school.

Immigrants in the economy

Immigrants in Contra Costa County, California, and the United States are indispensable members of the workforce and contribute to the economy by paying federal, state, and local taxes.

Tax contributions*

California

\$572.5B Immigrant-led households **earned \$572.5 billion**.

\$61.8B Immigrants contributed **\$61.8 billion** in combined **state and local taxes**.

\$106.3B Immigrants contributed **\$106.3 billion** in **federal taxes**.

\$404.4B This means that immigrant-led households have an estimated **\$404.4 billion** in **spending power**.

United States

\$2.35T Immigrant-led households **earned \$2.35 trillion**.

\$232.1B Immigrants contributed **\$232.1 billion** in combined **state and local taxes**.

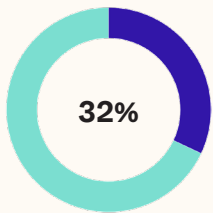
\$419.8B Immigrants contributed **\$419.8 billion** in **federal taxes**.

\$1.7T This means that immigrant-led households have an estimated **\$1.7 trillion** in **spending power**.

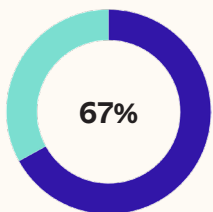

Contra Costa County

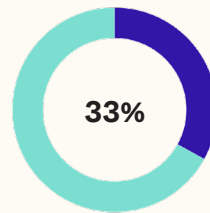


197,900 immigrant workers make up **32 percent** of the county's labor force.

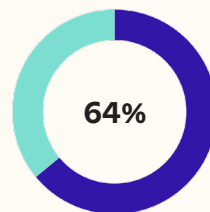


67 percent of the county's immigrants **participate in the labor force**, comparable to the share among the county's U.S.-born population (64 percent).

California



6.6 million immigrant workers make up **33 percent** of the state's labor force.



64 percent of the state's immigrants **participate in the labor force**, comparable to the share among the state's U.S.-born population (64 percent).
