

Immigrant population

Immigrants make up an important part of local communities in Illinois and the United States. Nonetheless, no noncitizen is exempt from the risk of deportation, which threatens the stability and family unity of immigrants and U.S.-born people alike.

Illinois



1.9 million immigrants reside in **Illinois**, or **15 percent** of Illinois's population.

United States



47.3 million immigrants reside in **the United States**, or **14 percent** of the total population.

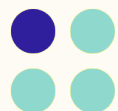

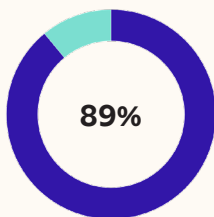

One in four children in Illinois has at least one **immigrant parent**.

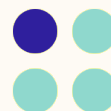


The **vast majority of children** in Illinois with at least one immigrant parent (**89 percent**) were born in the United States.

United States

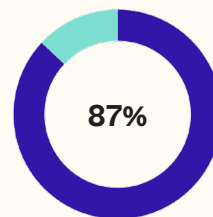

1.6 million immigrants residing in Illinois have lived in the United States **for 10 years or more**.



At least **677,900** homes in Illinois are **owned by immigrants**.



71,600 immigrants in Illinois are **entrepreneurs**.



203,000 immigrants in Illinois are **students** enrolled in pre-K through college or graduate school.

Immigrants in the economy

Immigrants in Illinois and the United States are indispensable members of the workforce and contribute to the economy by paying federal, state, and local taxes.

Tax contributions*

Illinois

\$95.9B Immigrant-led households **earned \$95.9 billion**.

\$10.6B Immigrants contributed **\$10.6 billion** in combined **state and local taxes**.

\$16.9B Immigrants contributed **\$16.9 billion** in **federal taxes**.

\$68.5B This means that immigrant-led households have an estimated **\$68.5 billion** in **spending power**.

United States

\$2.35T Immigrant-led households **earned \$2.35 trillion**.

\$232.1B Immigrants contributed **\$232.1 billion** in combined **state and local taxes**.

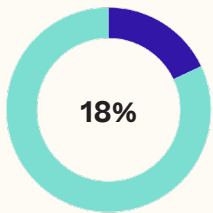
\$419.8B Immigrants contributed **\$419.8 billion** in **federal taxes**.

\$1.7T This means that immigrant-led households have an estimated **\$1.7 trillion** in **spending power**.

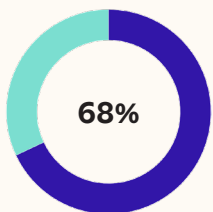

Illinois

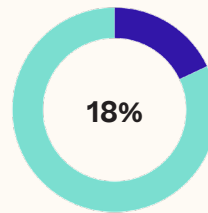


1.2 million immigrant workers make up **18 percent** of the state's labor force.

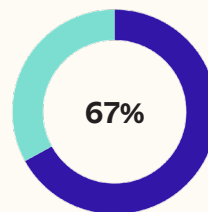


68 percent of the state's immigrants **participate in the labor force**, greater than the share among the state's U.S.-born population (64 percent).

United States



30.2 million immigrant workers make up **18 percent** of the country's labor force.



67 percent of immigrants **participate in the country's labor force**, greater than the share among the U.S.-born population (63 percent).
