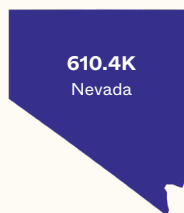


Immigrant population

Immigrants make up an important part of local communities in Nevada and the United States. Nonetheless, no noncitizen is exempt from the risk of deportation, which threatens the stability and family unity of immigrants and U.S.-born people alike.

Nevada



610,400 immigrants reside in **Nevada**, or **19 percent** of Nevada's population.

United States



47.3 million immigrants reside in **the United States**, or **14 percent** of the total population.

Noncitizen population

284.4K

284,400 noncitizens are living in Nevada.

22.6M

22.6 million noncitizens are living in **the United States**.

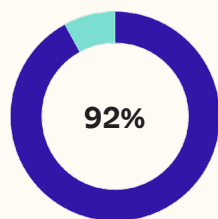

One in three children in Nevada has at least one **immigrant parent**.

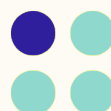


The **vast majority of children** in Nevada with at least one immigrant parent (**92 percent**) were born in the United States.

United States

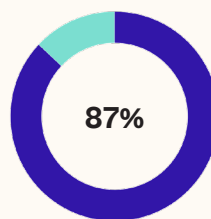
18.7M

Local community ties



542,300 immigrants residing in Nevada have lived in the United States **for 10 years or more**.



At least **210,700** homes in Nevada are **owned by immigrants**.



25,900 immigrants in Nevada are **entrepreneurs**.



46,300 immigrants in Nevada are **students** enrolled in pre-K through college or graduate school.

Immigrants in the economy

Immigrants in Nevada and the United States are indispensable members of the workforce and contribute to the economy by paying federal, state, and local taxes.

Tax contributions*

Nevada

\$25B Immigrant-led households **earned \$25 billion**.

\$1.8B Immigrants contributed **\$1.8 billion** in combined **state and local taxes**.

\$4B Immigrants contributed **\$4 billion** in **federal taxes**.

\$19.1B This means that immigrant-led households have an estimated **\$19.1 billion** in **spending power**.

United States

\$2.35T Immigrant-led households **earned \$2.35 trillion**.

\$232.1B Immigrants contributed **\$232.1 billion** in combined **state and local taxes**.

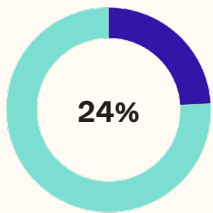
\$419.8B Immigrants contributed **\$419.8 billion** in **federal taxes**.

\$1.7T This means that immigrant-led households have an estimated **\$1.7 trillion** in **spending power**.

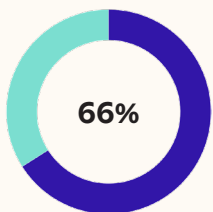

Employment and labor force participation

Nevada

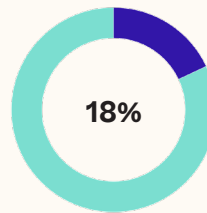


391,200 immigrant workers make up **24 percent** of the state's labor force.

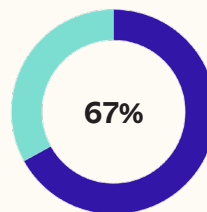


66 percent of the state's immigrants **participate in the labor force**, greater than the share among the state's U.S.-born population (62 percent).

United States



30.2 million immigrant workers make up **18 percent** of the country's labor force.



67 percent of immigrants **participate in the country's labor force**, greater than the share among the U.S.-born population (63 percent).
