

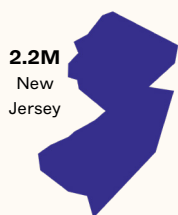

Immigrant population

Immigrants make up an important part of local communities in New Jersey and the United States. Nonetheless, no noncitizen is exempt from the risk of deportation, which threatens the stability and family unity of immigrants and U.S.-born people alike.

New Jersey



2.2 million immigrants reside in **New Jersey**, or **24 percent** of New Jersey's population.

United States



47.3 million immigrants reside in **the United States**, or **14 percent** of the total population.

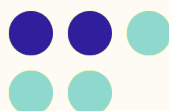

There are **835,700** children in New Jersey with at least one **immigrant parent**.



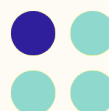

United States

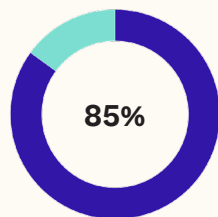

There are **18.7 million** children in the United States with at least one **immigrant parent**.

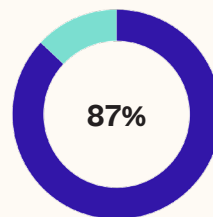

Local community ties



1.9 million immigrants residing in New Jersey have lived in the United States for **10 years or more**.



At least **639,800** homes in New Jersey are **owned by immigrants**.



88,500 immigrants in New Jersey are **entrepreneurs**.



254,600 immigrants in New Jersey are **students** enrolled in pre-K through college or graduate school.

Immigrants in the economy

Immigrants in New Jersey and the United States are indispensable members of the workforce and contribute to the economy by paying federal, state, and local taxes.

Tax contributions*

New Jersey

\$134.4B Immigrant-led households **earned \$134.4 billion**.

\$14.5B Immigrants contributed **\$14.5 billion** in combined **state and local taxes**.

\$25.4B Immigrants contributed **\$25.4 billion** in **federal taxes**.

\$94.5B This means that immigrant-led households have an estimated **\$94.5 billion** in **spending power**.

United States

\$2.35T Immigrant-led households **earned \$2.35 trillion**.

\$232.1B Immigrants contributed **\$232.1 billion** in combined **state and local taxes**.

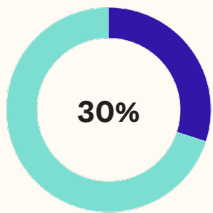
\$419.8B Immigrants contributed **\$419.8 billion** in **federal taxes**.

\$1.7T This means that immigrant-led households have an estimated **\$1.7 trillion** in **spending power**.

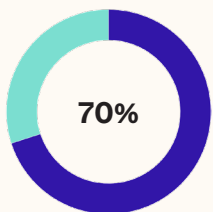

New Jersey

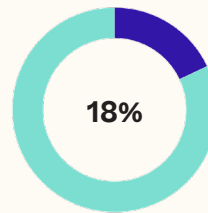


1.5 million immigrant workers make up **30 percent** of the state's labor force.

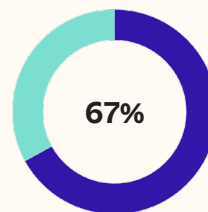


70 percent of the state's immigrants **participate in the labor force**, greater than the share among the state's U.S.-born population (65 percent).

United States



30.2 million immigrant workers make up **18 percent** of the country's labor force.



67 percent of immigrants **participate in the country's labor force**, greater than the share among the U.S.-born population (63 percent).
