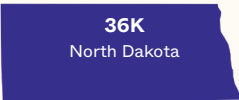


Immigrant population

Immigrants make up an important part of local communities in North Dakota and the United States. Nonetheless, no noncitizen is exempt from the risk of deportation, which threatens the stability and family unity of immigrants and U.S.-born people alike.

North Dakota



36,000 immigrants reside in **North Dakota**, or **5 percent** of North Dakota's population.

United States



47.3 million immigrants reside in **the United States**, or **14 percent** of the total population.

Noncitizen population

22.6 million noncitizens are living in **the United States**.

Children and families

There are **17,600** children in North Dakota with at least one **immigrant parent**.

United States

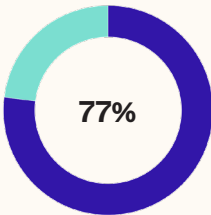

There are **18.7 million** children in the United States with at least one **immigrant parent**.

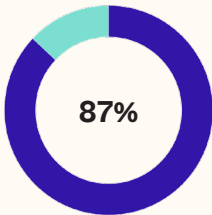

Local community ties



24,700 immigrants residing in North Dakota have lived in the United States for **10 years or more**.



At least **8,200** homes in North Dakota are **owned by immigrants**.



1,000 immigrants in North Dakota are **entrepreneurs**.



8,500 immigrants in North Dakota are **students** enrolled in pre-K through college or graduate school.

Immigrants in the economy

Immigrants in North Dakota and the United States are indispensable members of the workforce and contribute to the economy by paying federal, state, and local taxes.

Tax contributions*

North Dakota

\$1.5B Immigrant-led households **earned \$1.5 billion**.

\$96.7M Immigrants contributed **\$96.7 million** in combined **state and local taxes**.

\$275.2M Immigrants contributed **\$275.2 million** in **federal taxes**.

\$1.1B This means that immigrant-led households have an estimated **\$1.1 billion** in **spending power**.

United States

\$2.35T Immigrant-led households **earned \$2.35 trillion**.

\$232.1B Immigrants contributed **\$232.1 billion** in combined **state and local taxes**.

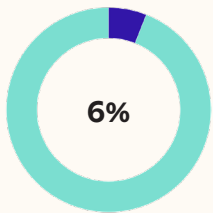
\$419.8B Immigrants contributed **\$419.8 billion** in **federal taxes**.

\$1.7T This means that immigrant-led households have an estimated **\$1.7 trillion** in **spending power**.

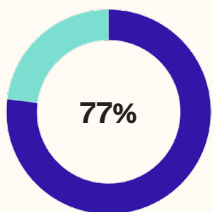

Employment and labor force participation

North Dakota

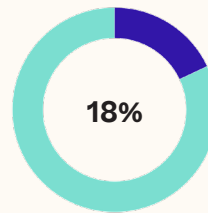


24,800 immigrant workers make up **6 percent** of the state's labor force.

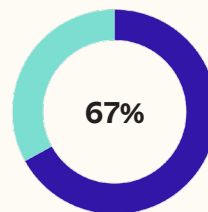


77 percent of the state's immigrants **participate in the labor force**, greater than the share among the state's U.S.-born population (68 percent).

United States



30.2 million immigrant workers make up **18 percent** of the country's labor force.



67 percent of immigrants **participate in the country's labor force**, greater than the share among the U.S.-born population (63 percent).
