# Immigrant population

Immigrants make up an important part of local communities in Oregon and the United States. Nonetheless, no noncitizen is exempt from the risk of deportation, which threatens the stability and family unity of immigrants and U.S.-born people alike.

404,200 immigrants reside in Oregon, or 10 percent of Oregon's population.

47.8 million immigrants reside in United States, or 14 percent of the total population.

### Oregon

171.7K children There are 171,700 children in Oregon with at least one immigrant parent.

The vast majority of children in Oregon with at least one immigrant parent (93 percent) were born in the United States.

### Local community ties



271,900 immigrants residing in Oregon have lived in the United States since 2009 or earlier.



At least 100,900 homes in Oregon are owned by immigrants.



18,400 immigrants in Oregon are entrepreneurs.



41,500 immigrants in Oregon are students enrolled in pre-K through college or graduate school.

# Immigrants in the economy

Immigrants in Oregon and the United States are indispensable members of the workforce and contribute to the economy by paying federal, state, and local taxes.

### Tax contributions\*

### Oregon

\$20B Immigrant-led households earned \$20 billion.

**\$2.1B** Immigrants contributed **\$2.1 billion** in combined **state and local taxes**.

\$3.5B Immigrants contributed \$3.5 billion in federal taxes.

\$14.3B This means immigrant-led households have an estimated \$14.3 billion in spending power.

#### **United States**

\$2.4T Immigrant-led households earned \$2.4

\$232.1B Immigrants contributed \$232.1 billion in combined state and local taxes.

\$419.8B Immigrants contributed \$419.8 billion in federal taxes.

\$1.7T This means immigrant-led households have an estimated \$1.7 trillion in spending power.

### Employment and labor force participation

### Oregon




**272,500** immigrant workers make up **12 percent** of the state's labor force.



**70 percent** of the state's immigrants participate in the labor force, greater than the share among the state's U.S.-born population (61 percent).

### **United States**



**30.7 million** immigrant workers make up **18 percent** of the country's labor force.



**68 percent** of immigrants **participate in the country's labor force**, greater than the share among the U.S.-born population (63 percent).
