# Immigrant population

Immigrants make up an important part of local communities in the Philadelphia metro area and Pennsylvania. Nonetheless, no noncitizen is exempt from the risk of deportation, which threatens the stability and family unity of immigrants and U.S.-born people alike.

### Philadelphia Metro Area



**718,500 immigrants** reside in **Philadelphia**, or **12 percent** of Philadelphia's population.

### **Pennsylvania**



1 million immigrants reside in Pennsylvania, or 8 percent of the total population.

There are **285,100** children in Philadelphia with at least one **immigrant parent**.

### **Pennsylvania**

411K children There are **411,000** children in Pennsylvania with at least one **immigrant parent.** 




Two in nine children in Philadelphia have at least one immigrant parent.

### Local community ties



**481,900** immigrants residing in the Philadelphia metro area have lived in the United States **since 2009** or **earlier**.



At least **192,900** homes in the Philadelphia metro area are **owned by immigrants**.



**30,300** immigrants in the Philadelphia metro area are **entrepreneurs**.



**96,400** immigrants in the Philadelphia metro area are **students** enrolled in pre-K through college or graduate school.

# Immigrants in the economy

Immigrants in Pennsylvania and the United States are indispensable members of the workforce and contribute to the economy by paying federal, state, and local taxes.

# Tax contributions\*

### Pennsylvania

\$49.5B Immigrant-led households earned \$49.5 billion.

\$4.8B Immigrants contributed \$4.8 billion in combined state and local taxes.

**\$8.8B** Immigrants contributed **\$8.8 billion** in federal taxes.

\$35.9B This means immigrant-led households have an estimated \$35.9 billion in spending power.

#### **United States**

\$2.4T Immigrant-led households earned \$2.4

\$232.1B Immigrants contributed \$232.1 billion in combined state and local taxes.

\$419.8B Immigrants contributed \$419.8 billion in federal taxes.


\$1.7T This means immigrant-led households have an estimated \$1.7 trillion in spending power.

# Employment and labor force participation

### Philadelphia Metro Area



**471,000** immigrant workers make up **14 percent** of the metro area's labor force.



**69 percent** of the metro area's immigrants **participate in the labor force**, greater than the share among the metro area's U.S.-born population (65 percent).

# Pennsylvania



**647,500** immigrant workers make up **10 percent** of the state's labor force.



**68 percent** of immigrants **participate in the state's labor force**, greater than the share among the state-born population (62 percent).
