Immigrants make up an important part of local communities in Prince George's County and Maryland. Nonetheless, no noncitizen is exempt from the risk of deportation, which threatens the stability and family unity of immigrants and U.S.-born people alike.

152,900 immigrants residing in Prince George's County have lived in the United States **since 2009 or earlier**.



At least **51,000** homes in Prince George's County are **owned by immigrants**.



13,000 immigrants in Prince George's County are **entrepreneurs**.



36,400 immigrants in Prince George's County are **students** enrolled in pre-K through college or graduate school.

Immigrants in the economy

Immigrants in Maryland and the United States are indispensable members of the workforce and contribute to the economy by paying federal, state, and local taxes.

Tax contributions*

Maryland

\$55.3B Immigrant-led households earned \$55.3 billion.

\$5.9B Immigrants contributed **\$5.9 billion** in combined **state and local taxes**.

\$9.9B Immigrants contributed \$9.9 billion in federal taxes.

\$39.5B This means immigrant-led households have an estimated \$39.5 billion in spending power.

United States

\$2.4T Immigrant-led households earned \$2.4 trillion.


\$232.1B Immigrants contributed \$232.1 billion in combined state and local taxes.

\$419.8B Immigrants contributed \$419.8 billion in federal taxes.

\$1.7T This means immigrant-led households have an estimated \$1.7 trillion in spending power.

Prince George's County




171,400 immigrant workers make up **32 percent** of the county's labor force.



Maryland



729,100 immigrant workers make up **22 percent** of the state's labor force.



74 percent of immigrants **participate in the state's labor force**, greater than the share among the state-born population (66 percent).
