

Immigrant population

Immigrants make up an important part of local communities in Utah and the United States. Nonetheless, no noncitizen is exempt from the risk of deportation, which threatens the stability and family unity of immigrants and U.S.-born people alike.

Utah



304,600 immigrants reside in **Utah**, or **9 percent** of Utah's population.

United States



47.3 million immigrants reside in **the United States**, or **14 percent** of the total population.

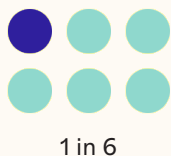

Children and families

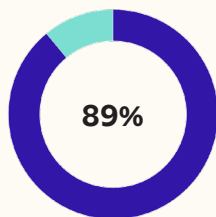

The **vast majority of children** in Utah with at least one immigrant parent (**89 percent**) were born in the United States.

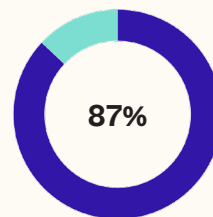
United States

Local community ties



240,800 immigrants residing in Utah have lived in the United States **for 10 years or more**.



At least **106,300** homes in Utah are **owned by immigrants**.



12,400 immigrants in Utah are **entrepreneurs**.



44,900 immigrants in Utah are **students** enrolled in pre-K through college or graduate school.

Immigrants in the economy

Immigrants in Utah and the United States are indispensable members of the workforce and contribute to the economy by paying federal, state, and local taxes.

Tax contributions*

Utah

\$12.2B Immigrant-led households **earned \$12.2 billion**.

\$1.2B Immigrants contributed **\$1.2 billion** in combined **state and local taxes**.

\$1.9B Immigrants contributed **\$1.9 billion** in **federal taxes**.

\$9.1B This means that immigrant-led households have an estimated **\$9.1 billion** in **spending power**.

United States

\$2.35T Immigrant-led households **earned \$2.35 trillion**.

\$232.1B Immigrants contributed **\$232.1 billion** in combined **state and local taxes**.

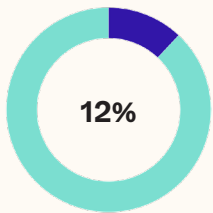
\$419.8B Immigrants contributed **\$419.8 billion** in **federal taxes**.

\$1.7T This means that immigrant-led households have an estimated **\$1.7 trillion** in **spending power**.

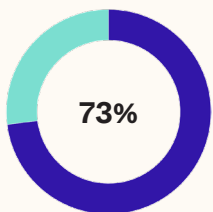

Utah

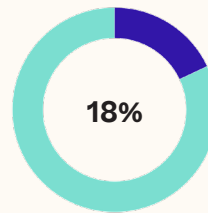


211,200 immigrant workers make up **12 percent** of the state's labor force.

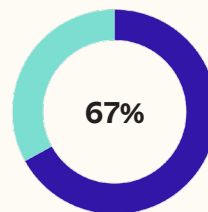


73 percent of the state's immigrants **participate in the labor force**, greater than the share among the state's U.S.-born population (69 percent).

United States



30.2 million immigrant workers make up **18 percent** of the country's labor force.



67 percent of immigrants **participate in the country's labor force**, greater than the share among the U.S.-born population (63 percent).
