The foreign-born population in Austin and Texas represent an important and diverse share of their local communities, many of whom live in mixed-status families.

Austin Metro Area



296,000 immigrants reside in **Austin**, or **14 percent** of the total population.

Texas



4.7 million immigrants reside in **Texas**, or **17** percent of the total population.

175,400 non-citizens residing in **Austin** are potentially at risk of deportation.

Children and families

Austin Metro Area



There are **144,700 children** in **Austin** with at least one immigrant parent.

Economic and labor force contributions

Immigrants in Austin and Texas contribute critical tax dollars to the local economy and are indispensable members of the workforce.

Austin Metro Area

\$8.1B immigrant-led households earned \$8.1 billion.

\$557M immigrants contributed \$557 million in combined state and local taxes.

\$1.5B immigrants contributed \$1.5 billion in federal taxes.

\$15.7B This means immigrant-led households have an estimated \$6.1 billion in spending power.

Texas

\$133.3B immigrant-led households earned \$133.3 billion.

\$9.6B immigrants contributed \$9.6 billion in combined state and local taxes.

\$22.5B immigrants contributed \$22.5 billion in federal taxes.

\$101.2B This means immigrant-led households have an estimated \$101.2 billion in spending power.

Labor force participation

Austin Metro Area



192,500 immigrant workers comprise 18 percent of the city's labor force, or **one in seven**.

Texas



2.9 million immigrant workers comprise 22 percent of the state's labor force, or **one in five**.



1 in 7

72 percent of the city's immigrants participate in the labor force, comparable to the share among the city's native-born population (71 percent).



1 in 5

67 percent of the state's immigrants **participate in the labor force**, greater than the share among the state's native-born population (64 percent).
