The foreign-born population in the San Francisco and California represent an important and diverse share of their local communities, many of whom live in mixed-status families.

Population at risk of deportation

648K **647,900 non-citizens** residing in **San Francisco** are potentially at risk of deportation.

5.3M **5.3 million non-citizens** residing in **California** are potentially at risk of deportation.

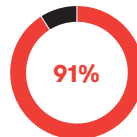

1.2 million immigrants in San Francisco have lived in the United States for **more than 15 years**.

157,000 immigrants in San Francisco are **students** enrolled in pre-K through college or graduate school.

Economic and labor force contributions

Immigrants in San Francisco and California contribute critical tax dollars to the local economy and are indispensable members of the workforce.

San Francisco Metro Area

\$56.8B immigrant-led households **earned \$56.8 billion.**

\$4.6B immigrants contributed **\$4.6 billion** in combined **state and local taxes.**

\$11.9B immigrants contributed **\$11.9 billion** in **federal taxes.**

\$40.3B This means immigrant-led households have an estimated **\$40.3 billion** in **spending power.**

California

\$367.6B immigrant-led households **earned \$367.6 billion.**

\$30B immigrants contributed **\$30 billion** in combined **state and local taxes.**

\$69.4B immigrants contributed **\$69.4 billion** in **federal taxes.**

\$268.3B This means immigrant-led households have an estimated **\$268.3 billion** in **spending power.**

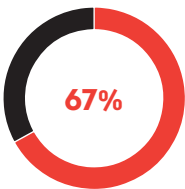
Labor force participation

San Francisco Metro Area



894,700 immigrant workers comprise 36 percent of the city's labor force, or **one in three.**

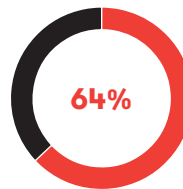
67 percent of the city's immigrants **participate in the labor force**, comparable to the share among the city's native-born population (67 percent).

California



6.3 million immigrant workers comprise 34 percent of the state's labor force, or **one in three.**

64 percent of the state's immigrants **participate in the labor force**, comparable to the share among the state's native-born population (63 percent).
